

## **Missional Generation Digital privacy policy**

This Privacy Policy governs the manner in which Missional Generation CIO collects, uses, maintains and discloses information collected from users. This privacy policy applies to the Augmented Reality and Virtual Reality and Static MG apps offered by Missional Generation.

#### Personal identification information

We never collect data from your camera, and never upload it anywhere. Data from your camera stays on your device at all times.

We may collect personal identification information from Users in a variety of ways in connection with activities, services, features or resources we make available on either AR and VR apps or MG app. Users may use our products anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personal identification information by typing N/A in any fields, except that it may prevent them from engaging in certain activities.

### Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with our products. Non-personal identification information may include the browser name, the type of computer and technical information about Users means of connection to our products, such as the operating system and the Internet service providers utilized and other similar information.

#### Web browser cookies

Our Site may use "cookies" to enhance User's experiences. User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. The user may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of our products may not function properly.

#### How we use collected information

Missional Generation collects and uses User's personal information for the following purposes:

- To be able to address and fix any bugs and maintain the functionality of all our products
- To send push notifications about updates
- To collect a general sense of usage of our products (please note, we do not collect or store any personal details that would identify the user).

#### How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our products.

# **Sharing your personal information**

We do not sell, trade, or rent Users personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our partners and trusted affiliates.
